Treasurers Report:

- Financial statements accommodation income increased, however higher electricity
- \$22,770 (\$18,737) net profit for 2018
- cost to run and maintain the lodge \$81,860 (\$76,343)
- Spent \$12,000 in renovation of the lodge end of Dec plus \$6000 in 2019 to date.
- Recovery of revenue from members, members who have been suspended for not paying levies \$9,536
- Owing the end of year levies \$11,780 Still being contacted to recover
- Any excess of two years owing membership will be cancelled and no booking allowed if still un-financial
- Interest rates are lower
- Keeping cash available for building works
- Expenses bought new pillows and a blanket
- fire alarm inspection supplier changed
- insurance increased due to re valuation of lodge in 2018
- Water and sewerage is lower due to an accrual
- Balance sheet term deposits, cash in bank \$22,000 after expenses on renovation
- Question from Sue Gai Hood Need for special levies? So far, we have managed on the savings
- Lodge insured for 2.4mil
- Adam Adair question to membership cancellation (suspension) , has the rule changed board to check cooperative rules
